

(Usage and Dosage)

For adults (15 years and above) and children aged 7 years and above: Spray 1 to 2 times into the nasal cavity per application, 1 to 5 times per day. Additionally, maintain an interval of at least 3 hours between uses. Usage method

(1) Store in a cool place away from direct sunlight and keep the lid securely closed.

(2) Place out of reach of children.

(3) Do not transfer to another container. (This may lead to misuse or alter the quality of the product.)
